The current healthcare model focuses on treating illnesses after they occur, leading to late diagnosis, substantial economic costs, and a lack of medical resources. As preventative care is underused or known of, it continues contributing to oftentimes fatal consequences on illnesses that could've been prevented. The lack of public awareness, the challenge that resource allocation brings when there's not enough budgeting and different cultural beliefs towards health impede the effective implementation of preventative care.

Several countries like France, Germany, Canada, and Sweden have initiated preventative care programs that incorporate vaccinations, screenings, and lifestyle changes; however, the same effort has yet to be seen throughout the globe.
